

## BUBBL'R BOOST YOUR FUTURE PROMOTION OFFICIAL RULES

### NO PURCHASE NECESSARY IN THIS PROGRAM. VOID WHERE PROHIBITED

**1. PROGRAM PERIOD:** The BUBBL'R "Boost Your Future" Program (the "Program") Period begins on May 23<sup>rd</sup>, 2022, at 11:30 AM Central Time ("CT") and ends on August 8<sup>th</sup>, 2022, at 4:00 p.m. CT (the "Program Period"). The Judging Phase begins August 8<sup>th</sup>, 2022, at 4:01 p.m. CT and ends on August 12<sup>th</sup>, 2022, at 4:00 p.m. CT. The Voting Period will begin on August 12<sup>th</sup>, 2022, at 4:01 PM CT and will end on September 2<sup>nd</sup>, 2022, at 4:00 PM CT. The winners will be announced on September 5<sup>th</sup>, 2022. Sponsor may terminate this Promotion at any time.

**2. ELIGIBILITY:** The Program is open to legal residents of the United States as of May 23<sup>rd</sup>, 2022, who, at the time of participation and entry, are at least the age of majority in their state of residence and reside in one or more of the states in which the Program is made available by the respective local BUBBL'R distributors OR be the age of nine (9) at the time of entry and have the permission of their parent or legal guardian ("Parent") prior to entering and: (i) reside in one or more of the states in which the Program is made available by the respective local BUBBL'R distributors. Participation constitutes an entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are and shall be final and binding in all respects. Sponsor reserves the right to disqualify any participant determined, in Sponsor's sole judgment and absolute discretion, to be (a) tampering or attempting to tamper with the entry process or the operation of the Program; (b) violating the Official Rules of the Program; or (c) acting in an unsportsmanlike or disruptive manner, or with the intent to annoy, abuse, threaten, harass or act fraudulently in any manner. PROGRAM VOID WHERE PROHIBITED BY LAW OR REGULATION.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Promotion.

**3. SPONSOR:** Program sponsor is Wis-Pak, Inc., 860 West Street, Watertown, WI 53094. All decisions regarding all matters and aspects of and relating to the Program shall be made by Wis-Pak, in its sole and absolute discretion, and all such decisions shall be final,

binding and conclusive. This includes materials submitted for verification, and the eligibility of participants. By entering this Program, entrant agrees to these Official Rules and to the binding, final and conclusive nature of Sponsor's decisions.

**4. HOW TO ENTER THE CONTEST:** During the Program Period, an eligible entrant must visit [www.boostyourfuture.com](http://www.boostyourfuture.com) ("Website") and enter his/her valid e-mail address and the information requested on the entry form, which may include, without limitation: his/her first and complete last name (no initials); valid e-mail address; phone number; street address (no P.O. Boxes will be allowed); city, state; and zip code. Entrant must then follow the on-screen prompts to link to a TikTok video, Instagram video, or upload a video (60 seconds or less, 250 MB, in one of the following file formats: .MOV, .MPEG, .WMV, .MP4) ("Video") declaring why they are deserving of a monetary prize to "boost their future" whether it be used for college scholarship funds, to start a business, to follow their passion, etc., collectively a ("Submission"). **All Submissions must comply with the restrictions outlined below.**

**Limit:** There is a limit of one (1) unique Submission per person during the Program Period. An entrant who attempts to enter more than the stated limit may be subject to disqualification from the Promotion. If it is discovered or suspected that a person has attempted to enter or upload Submissions using multiple e-mail addresses or identities, all of that person's Submissions may be declared null and void and that person will not be awarded any prize that he/she might have been entitled to receive and such prize may be forfeited, at the Sponsor's sole and absolute discretion.

- Must be original work of the entrant and must not contain images or artwork, music, quotes, parodies or other materials not created by the entrant;
- Must not feature brand names, logos, or trademarks other than Sponsor's trademarks in any other element of the entry or image, which Sponsor has granted, with respect to the Sponsor's trademarks, entrant limited license to use for the purpose of this Promotion;

- Must not contain, facilitate, reference, or use material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, gender, ethnicity, religion, nationality, disability, sexual orientation, political orientation, citizenship, ancestry, marital status, or age; and
- Must not contain material that is unlawful, in violation of or contrary to the laws or regulations in any jurisdiction where the Video was created.

Entrant must have approval from any persons appearing in the Submission and be able to provide express written consent of every such person appearing in the Submission to Sponsor and/or Administrator if requested.

**NOTE:** If any entry fails to comply with any of these Submission Requirements or any other provisions of these Official Rules, Sponsor and Administrator reserve the right to disqualify the entrant.

Once a Submission is submitted in the Promotion it may be made available on Sponsor's social media accounts or other websites for viewing by the general public and any such posting will be deemed made at the direction of the entrant within the meaning of the Digital Millennium Copyright Act and the Communications Decency Act.

**6. JUDGING PHASE:** The Judging Phase begins August 8<sup>th</sup>, 2022, at 4:01 p.m. CT and ends on August 12<sup>th</sup>, 2022, at 4:00 p.m. CT. During the Judging Phase, the assigned judges will use the following "Judging Criteria" to select the top 15 submissions that will move forward into the Voting Phase. Judging Criteria: 25% (i) Creativity, 25% (ii) Storytelling, 25% (iii) Talent, and

25% (iiii) How well they explain their passion and what they plan on doing with the prize money. After the judges assess all of the submissions, the top 15 submissions, will be added to the website for the public to vote for during the Voting Phase.

**7. VOTING PHASE:** During the Voting Phase (August 12<sup>th</sup>, 2022, at 4:01 p.m. CT to September 2<sup>nd</sup>, 2022 at 4:00 p.m. CT), the top 15 submissions chosen during the Judging Phase, will be uploaded to the website and will be available for people to vote for their favorite submission. Each voter may vote one time per day during the Voting Phase. During the Voting Phase, a person who is a legal resident of the fifty (50) United States or District of Columbia and eighteen (18) years or older may vote for his/her favorite Submission. A person who satisfies the eligibility requirements set forth in Section 2 may vote for his/her favorite entry and enter the Sweepstakes. The voter must visit the [www.boostyourfuture.com](http://www.boostyourfuture.com) (“Website”) and follow the onscreen instructions to vote. Each voter may vote one (1) time per day during the Voting Phase. Votes received from any person or e-mail address or household in excess of this limitation will be void. Votes generated by script, BOT, macro or other automated means are void. Voting must be completed by the actual person casting the vote. A person may not vote on behalf of another person. Subsequent votes during one calendar day by a single voter or e-mail address will be disqualified. Votes intended to impact the integrity of the voting process as determined by Sponsor in Sponsor’s sole discretion are void. Payment or other consideration in exchange for votes is prohibited.

The top 15 submissions will all receive a monetary prize. The top 3 submissions with the most votes at the end of the voting period, will each receive a larger monetary prize. Each Contest winner is a potential winner pending verification of eligibility and compliance with the Official Rules. In the event there are any ties, the tied Submissions will be judged again and the Submission chosen by a panel of judges, will prevail. If a potential winner is found to be ineligible or does not comply with these Official Rules, or otherwise does not accept his/her prize as awarded, he/she will be disqualified and the nominee in the Submission with the next highest number of votes will be named a potential winner. selection of the winners. The winners will be announced on September 5<sup>th</sup>, 2022

## **8. PRIZES AND APPROXIMATE RETAIL VALUE (“ARV”):**

- 1. Contest Grand Prize (1):** The Contest grand prize is \$20,000 (“Contest Grand Prize”). There will be one (1) Contest Grand Prize in the Promotion awarded to the 1<sup>st</sup> place submission. The ARV of the Contest Grand Prize is \$20,000.
- 2. Contest Second Prize (1):** The Contest second prize is \$10,000 (“Contest Second Prize”). There will be one (1) Contest Second Prize in the Promotion awarded to the 2<sup>nd</sup> place submission. The ARV of the Contest First Prize is \$10,000.
- 3. Contest Third Prize (1):** The Contest third prize is \$5,000 (“Contest Third Prize”). There will be one (1) Contest Third Prize in the Promotion awarded to the 3<sup>rd</sup> place submission. The ARV of the Contest Third Prize is \$5,000.

**9. WINNER VERIFICATION:** Potential winners are subject to verification of eligibility and compliance with these Official Rules. Sponsor or Administrator will get each potential nominee winner’s contact information from the nominator/entrant. Sponsor or Administrator will notify each potential Sweepstakes winners and Nominator Prize winners via email with instructions on how to redeem his/her respective prize. Each potential Contest winner will be required to sign and execute an Affidavit of Eligibility, a Liability Release, and (where imposing such condition is legal) within five (5) days of prize notification.
